Look what you've done through NCA!

RECENT WINS FOR CATTLEMEN:

- **Ag Credit:** Because of NCA's work on the new Farm Credit Bill, NCA Immediate Past President, Jack Dahl, was nominated by President Reagan as the first Chairman of the permanent Federal Farm Mortgage Corporation. This secondary market should increase the availability of long-term ag credit at stable, competitive interest rates.
- **Animal Patents:** The House passed a bill which NCA worked hard on to exempt farmers from paying royalties on the offspring of patented animals.
- **Beef Healthfulness:** Largely due to NCA efforts, the Senate passed the Nutrition Monitoring Act which requires federal agencies to 'speak with one voice' when issuing dietary guidance. This will help to ensure that the true facts about beef are always considered whenever the government issues future diet advice.
- **Beef Promotion:** Beef producers overwhelmingly approved continuation of the \$1 checkoff program initiated by NCA. The program has proven to be one of the most positive steps for the U.S. beef industry by returning an estimated \$1 billion to producers every year. NCA was responsible for making the national checkoff possible:
 - 1985— Lobbied Congress to pass the Beef Promotion & Research Act.
 - 1986— Petitioned the U.S. Secretary of Agriculture to sign the Order which started the checkoff program.
 - 1987/88— Worked aggressively on a successful campaign to pass the checkoff referendum.
- **Beef Purchases:** By restoring the 'Buy American' provision to a defense authorization bill, NCA helped prevent the loss of \$89.4 million in annual sales of beef to U.S. military for feeding troops overseas.
- **Commercial License Regulations:** NCA played a key role in obtaining an exemption for most beef cattle producers from proposed new commercial driver's license requirements. This win saved cattlemen from having to test for

and purchase the \$50-\$100 license. NCA noted that "interpretation of the law to include farm operators is an additional regulatory burden on those individuals".

- **Drought Assistance:** At the request of NCA, U.S. Ag Secretary Lyng announced that USDA would purchase an additional \$50 million of meat to help offset the effect of drought on the cattle market. This purchase resulted in an increased return of approximately \$5-8/head sold. NCA also helped to secure a \$40 million line of credit to Mexico for beef purchases and worked to see that federal feed assistance programs were fair for all livestock producers.
- **Japanese Market:** NCA won a major victory for U.S. cattlemen with the formation of a new U.S./Japan beef trade agreement. NCA played a leading role in helping to reach this agreement which should double U.S. beef exports to Japan within 3 years. This could increase fed cattle prices by almost \$2.00/cwt when the market is liberalized.
- **Water Rights:** NCA won another battle for cattlemen when the Departments of Interior and Justice determined that wilderness designation does NOT create new federal water rights. NCA has fought long for this decision which preserves water rights and allows a state to allocate its water as it sees fit.

NO NEWS IS GOOD NEWS!

- NCA plays "defense" to prevent potentially negative publicity from making front-page news. These "behind-the-scenes" victories are highly beneficial to our industry.
- Took action to inform media, retailers, the industry and key influencers about the beef price/supply situation as it related to the drought. Sent out over 3000 radio and T.V. news releases to inform consumers that the drought was NOT causing higher beef prices.
 - NCA responded immediately to media inquiries and answered questions about the effect of the new Finaplix implant on quality grading. This action prevented the complex issue from developing into an unwarranted concern over beef safety.

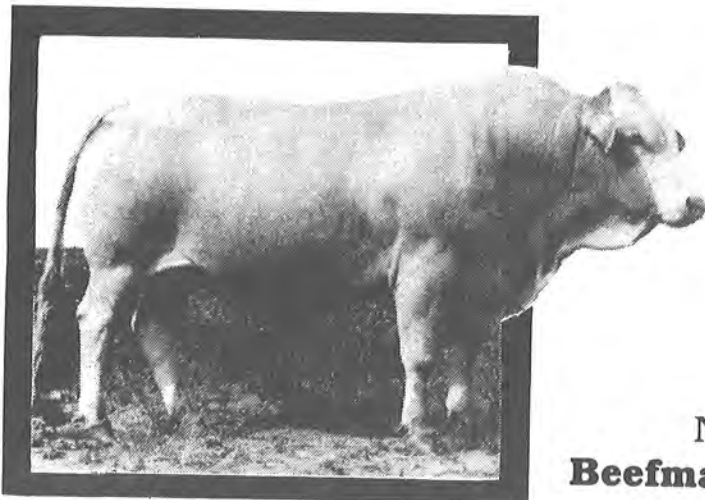

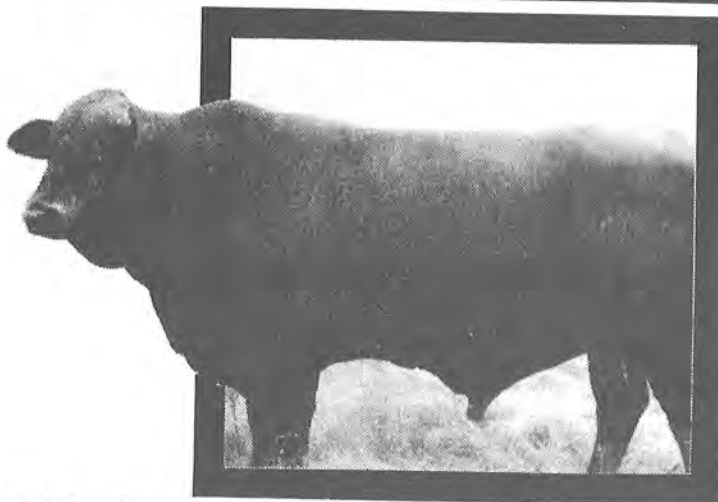

BEEF "ON" FORAGE BEEFMASTER BULL TEST

On December 19, 1987 fourteen members of the Central Texas Beefmaster Breeders (members of the Foundation Beefmaster Association) delivered 52 Foundation Beefmaster bulls to the Clifton Marek Ranch south of Lexington, Texas for the second Annual Beef "ON" Forage bull performance test. The bulls are being tested under the guidelines of the Texas Forage and Grassland Bull Development Program.

The purpose of this test is to identify those bulls having a superior genetic ability to convert forages to beef by comparing contemporaries within an age and breed group in a uniform grazing environment. The 52 bulls delivered average 10½ months of age and all are within 90 days of age. The 300 day development program consists of a winter phase and summer phase, with bull's weights being taken every 28 days. At the conclusion of the 140 day winter phase of the test, the 52 bulls averaged 3.20 pounds per day gain, weighed 1230 pounds and had an average ribeye of 13.6 square inches with .20" fat thickness.

The remainder of the test, summer phase, will conclude with the Beef "ON" Forage Beefmaster Bull Sale October 22, 1988, 1:00 p.m., to be held at the Washington County Fairgrounds, Brenham, Texas. Each bull will sell with a complete performance evaluation to include: adjusted 205 day w.w, gain weights, weight per day of age, ultra-sound ribeye measurements and scrotal circumference.
